**A. TERMS AND CONDITIONS:**

1. Completed application form with the prescribed payment must be posted or paid bank to bank or paid in person. Overseas applicant must advise when payment has been made through Bank-to-Bank remittance and bank charges cannot be deducted from the rental fee.
2. The selection of display booth and market stall is based on FIRST PAID, FIRST SERVED BASIS.
3. Applicants must attach to their application form copy of Current Business Public Indemnity Liability Insurance (valid for 1 day or 1 year) to cover all their workers and customers.
4. Exhibitors must maintain cleanliness at all times – prior, during and after the event. Exhibitors must only display and sell quality products..
5. Stallholders are not allowed to consume or sell alcohol, beer and spirit during the event which is strictly alcohol-free (penalties will apply).
6. Stallholders' business-related fliers, brochures and promo materials are the ONLY fliers are allowed to be distributed during the event; provided, that they are of high quality/standard and sample/s have been attached to the application form.
7. In fairness to paying exhibitors and stallholders, non-stallholders will only be allowed to distribute fliers and promo materials upon payment of fee equivalent to the cost of stall rental. Unauthorized materials will be confiscated.
8. Trade exhibitors or representatives must attend the Stall Selection Meeting and Final Briefing that will be scheduled prior to the event. Failure to attend these meetings shall mean automatic cancellation of the application. Mutual arrangement for overseas exhibitors must be arranged so (as not to compromise) not to disadvantage its application.
9. Trade exhibitors must respect the rights of other stallholders on such matters as safety, noise, cleanliness, and space occupancy, among others.
10. Exhibitors must not display, demonstrate or sell to the public any dangerous and prohibited goods.
11. Trade exhibitors who are authorized to sell Fiesta-Kultura entry and raffle tickets, or solicit advertisements for the souvenir program, must remit the collected money no later than the Final Stallholders Meeting, and

they are prohibited from selling the same tickets during the event, especially within the premises or vicinity of the event.

12. In the event of cancellation, only partial refund of stall rental fee shall be allowed to cover administrative costs, as follows: less 10% if made more than 30 days prior to the event; less 20% if made more than 20 days prior to the event; less 30% if made more than 10 days prior to the event; and less 40% if made less than 10 days before the event.
13. Stallholders have equal chances to win Stall Incentive Awards that may consist of: (i) Best Presented Booth /Market Display, (ii.) Best Creative and Innovative Stall, and (iii.) Best Authentic Philippine Motif.
14. The stall trading hours during the event shall be from 9am to 8pm and clean-up time shall be from 8pm to 11pm. Vehicles will be allowed inside the fiesta premises from 9pm or at the close of the stage program (beauty pageant), whichever comes first.
15. Philippine and Australian export permit(s) must be secured to cover container shipment to Australia. The same shipment will comply with Australian Customs & Quarantine requirements such as fumigation and certificates of compliance from Country of Origin if necessary.
16. The large volume of product container shipment for display at this event must be avoided unless the Company has a local distributor who will take care of the goods after the event.
17. The Philippine and overseas products for exhibition must qualify and pass the Australian Quarantine requirements to avoid penalty and destruction upon entry to Australia. No banned items, prohibited or illegal goods and substances in any quantity will be included in any shipment(s).
18. All import Taxes, shipment's and delivery and related cost/s from Manila-Sydney-Manila terminals must be shouldered by the exhibitor/s. All products to be sold must be declared on the Bill of Lading and Brokerage Documents for Australian Custom and must pay the described import taxes upon entry to Australia. Any display products not sold are required to be returned to P.I. and pay associated cost of removal. Display products must leave the Philippines or country of origin not later than SIX WEEKS or appropriate time to allow Australian Custom and Quarantine inspection and clearing period upon entry to Aust.
19. The PASC will NOT receive any deliveries on behalf of any stallholders or trade exhibitors.
20. The PASC, Inc. reserves the right to refuse any application for whatever reason it deems necessary. Non-compliance of any of these terms and conditions will ban the offending party/s from future events.
