## LITTLE MISS PHILIPPINES-AUSTRALIA & LITTLE MISS CHARITY QUEEN AUSTRALIA

### Section 1: Objectives

1. To encourage children to participate in and appreciate the Philippine-Australian culture and tradition.
2. To develop poise, confidence, sportsmanship and teach children to perform their very best
3. To make new friendships

### Section 2: Policies, Rules & Regulations

Applicants and parents/guardians must agree to look solely to the PASC Inc Directors and Pageant Committee members with respect to all matters relating to the application, rules, regulations, policies, preparation, rehearsal, performance and all other matters relating to the pageant.

Applicants and parents/guardians are required to comply with all set guidelines, rules and conditions of the pageant as set out by the Pageant Committee and approved by the PASC Inc. Board of Management.

Application deadline is Monday 16<sup>th</sup> July but could be subject to change.

### Application Criteria

- Applicants must be 3 years to 6 years of age (as at 1<sup>st</sup> October 2018).
- At least one parent of the applicant must have Filipino heritage.
- It is a condition of entry that each applicant is to have at least one page of souvenir program advertisement and sell at least \$500 worth of raffle tickets.
- Applicants must submit at least 3 photographs with at least 1 headshot

### Rehearsals

Applicants are expected to be on time and present for all scheduled rehearsals and events leading up to and during the pageant. Applicants and parents/guardians agree to attend all rehearsals. All rehearsals are closed. Only applicants, parents/guardians and pageant staff will attend.

Dates and rehearsal venue will be advised.

### Section 3: Judges and Judging

#### Little Miss Charity Queen Australia

The winner of this title is the highest fundraiser based on raffle ticket sales and souvenir program advertisements. Applicants and parents/guardians must adhere to the following due dates for the remittance of all monies from proceeds of sold raffle tickets and advertisements. Any unsold raffle tickets are likewise returned on the final day of counting.

**First Counting** - Sunday, 19<sup>th</sup> August 2018 - advertisements in souvenir program & raffle tickets;

**Second Counting** – Sunday, 9<sup>th</sup> September 2018 additional advertisements and raffle tickets. Minimum one page advertisement and \$500 worth of raffle tickets must be remitted.

**Final Counting** – Wednesday, 26<sup>th</sup> September 2018 final solicited advertisements & raffle tickets

Any monies received after final counting deadline will not be counted towards Little Miss Charity Queen Australia. Applicants and parents/guardians will not receive their commission unless ALL proceeds of sold/unsold raffle tickets are remitted, and ALL advertisements are paid for.

Any changes to the above due dates or details for the remittance of monies will be advised separately.

### **Commission for Participation**

Commission for participation will be as follows: 10% for raffle ticket sales and 10% for advertisements on the souvenir program and sponsorship. These commissions are applicable for both the organization supported and family supported applicants.

### **Little Miss Philippines Australia**

The winner of this title is decided by a panel of judges selected by the Pageant Committee. Each applicant is judged based upon their merits according to the criteria specified on the score sheets.

The decision of the board of judges is final and non-contestable.

#### **Areas of competition:**

##### **Filipiniana - 25%**

Judges will score based on general appearance, stage presence, and charm.

##### **Swimwear - 25%**

Judges will score based on display of energy, charisma, expression and sense of fun and confidence.

##### **Evening Gown - 25%**

Judges will score based on overall first impression and her beauty and elegance.

##### **Question and Answer - 25%**

Judges will score based on appropriate, sensible answer, ability to communicate, voice and confidence and poise.

**Requirements for each section will be communicated separately.**

#### **Special Titles:**

Presented on coronation day. These are:

- **Little Miss Popularity:** This award will be given to the applicant with the most votes as determined by the public.
- **Little Miss Photogenic:** This will be judged by our official photographers during rehearsals, and photos submitted.
- **Little Miss Filipiniana:** This is awarded based on judges' scores
- **Cute in Swimwear:** This is awarded based on judges' scores.
- **Little Miss Elegant:** This is awarded based on judges' scores for the evening gown.

### **Section 5: Prizes**

Little Miss Philippines-Australia and Little Miss Charity Queen Australia will each receive \$1500 cash prize.

Little Miss Philippines-Australia Runner-Up and Little Miss Charity Princess Australia will each receive \$700 cash prize.

PASC Inc. reserves the right to replace a prize with another prize of equivalent value if the prize cannot be awarded in the manner described. As more sponsors are added, the prize list will be updated and printed in the souvenir program. Prizes must be claimed within the current financial year of the competition, otherwise prizes are forfeited.
